On February 16, 1937 the qualified voters within the vicinity of Orange Cove, California, assembled at the polls to decide by vote whether or not the Orange Cove Irrigation District should be organized and also to elect officers for the District.

The officers to be three directors, a treasumer, assessor and collector.

The District was to be devided into three divisions with one director to serve each division. The assessor collector and treasurer to serve the entire district. The district being composed of some twelve thousand acres.

The purpose of the formation of the district was to negotiate with the Central Valleys Water Project authorities for the purchase of water from the proposed Friant-Kern Canal.

A qualified voter was any registered voter residing within the limits of the District, with the exception of those residing within the limits of the town of Orange Cove.

The elecotrs approved the formation of the District by an almost unanimous vote, there being but one contrary vote.

The officers elected were as follows: For Director First Division W. W. Arkley, Senond Division M. N. Jensen, Third Division Geo. Zaninovich, Treasurer C. E. Ray, Assessor A. L. Schoepf, Collector, G. E. Bornefeld.

Directors M. A. Jensen and George Zaninovich are to serve four year terms and Director W. W. Arkley to serve a two-year term.

judge of the Superior Court of Fresno County for approval.

The certificates of election together with a memorandum of the names of the persons who paid a voluntary contribution of twentyfive cents per acre before the District was organized by vote, were turturned over to the Secretary who was authorized to rent a safety deposit box at the First National Bank of Orange Cove.

The papers were deposited and two keys are held by the Secretary.

No particular office or meeting place for the transaction of business was specified, it being agreed that the officers were to keep the accounts at their homes.

Mr. Jensen however offered the use of his office and equipment.

The meeting was then adjourned.

The Directors and Treasurer waived all compensation for the present. Compensation of the Assessor and Secretary was to be decided upon at a later meeting.

The above water rights having been in the name of the now dissolved Foothill Irrigation District. The rights were deeded to Mr. Wright with the idea that should another district be formed he, Mr. Wright, should transfer the deed to the new district.

The secretary was instructed to have the deed recorded and to advise the Department of Public Works at Sacramento of the transfer.

Mr. Donald Case appeared before the Board to ask for the inclusion of four-hundred acres of new land into the District. The Directors were agreeable to the inclusion, however Mr. Case was advised that in view of the expense persuant to the procedure it would be advisable to wait in event other land holders should also desire to be included in the District, thereby reducing the expense and work for all concerned. Mr. Case was advised that it was entirely up to himself should he desire to petition the State Engineer for the inclusion of his property.
