A move was made by M. N. Jensen and seconded by W. W. Arkley to instruct the Collector to publish the delinquent list according to law. Move passed.

It was moved by W. W. Arkley and seconded by M. N. Jensen that the Secretary be authorized to refund the money paid to the organization committee by voluntary contribution amounting to \$909.63. Move carried.

District business was as follows;

Motion by W. W. Arkley and seconded by M. N. Jensen to appoint an auditing committee to inspect the books of the district every six months. Motion carried. Directors M. N. Jensen and W. W. Arkley were appointed as auditing committee by the President of the Board of Directors, Mr. Geo. Zaninovich.

Motion by W. W. Arkley and seconded by M. N. Jensen to pay all bills presented by the secretary. Motion carried.

The bills were as follows; bill of E. M. Sheridan for \$250.00 for services rendered in organizing district. Bill of The Orange cove News for printing delinquent notices, \$26.25. Bill of M. A. Tisdel for \$2.40 for increase in car insurance of the Assessor-Collector. Bill of A. L. Schoepf for \$22.80 for time and milage.

The secretary was instructed to write to Mr. Holley, enclosing a form prepared by Mr. Jensen to be filled out by the land owners covering this information, asking his opinion as to wether this form would be suitable or if he had forms for this purpose.

The Secretary was instructed to mail the forms to each land owner.

Minutes of the meeting of the Board of Directors of the Orange Cove Irrigation District, April 12, 1938.

The regular meeting scheduled for April 5th was postponed to April 12th for lack of a quarum.

Those present were Directors George Zaninovich, W. W. Arkley, M. N. Jensen, Assessor-Collector-Secretary A. L. Schoepf.

Treasurer C. E. Ray was absent. The secretary acted for the treasurer in reading the treasurer's report.

Thenminutes of the previous meeting were read and approved. Bills for the month of March were presented and approved.

A motion was made by M. N. Jensen and seconded by W. W. Arkley that the following bills be paid. Bill of A. L. Schoepf for time and mileage as Assessor-Collector; \$53.25. Riege Stationery Co. \$6.59, for a post binder and sheets. Cutler-Crosi Courier for \$21.51 for publishing legal notices; Orange Cove News for printing office supplies, \$25.49.

The report of the Collector of funds collected for month of March and turned over to the treasurer was read. The amount was \$157.15

The report of the treasurer to the secretary of funds received from the collector for March was as follows; Amount received, \$157.15. Bank Balance of March 1st, 1938, \$2346.47. Checks drawn and returned through Bank, \$523.70. Bank balance as of April 6th statement \$1979.92. Both reports were filed with the Secretary.

The Collector read a report of the total collections and expenditures to date as follows; Collections to April 6th, 1938, \$4315.00, Total checks drawn \$2367.58, total oweing to district \$120.68. Total amount to be collected by assessment was \$4405.68 exclusive of penalties, costs and interest on delinquents. Total acreage assessed was 12587.72 acres. Amount sold to District for delinquent taxes on March 11th, 1938 was \$114.53. Certificates of Sale for each parcel were executed by the secretary and sent to the County Recorders of Freano and Tulare Counties for filing.

During March questionnaires were sent to all landowners in the district asking for information concerning the amount of developed and undeveloped land, water conditions, cost of power and future requirments of water. This information was required by Mr. Carl Holly, engineer for the Bureau of Reclamation.

The annual report on the financial condition of the district, acreage of citrus and deciduous trees, vines, grains, population, valuation of land, etc., as required by the California Districts Securities Commission was compiled by the secretary and sent in. A copy was also sent to the Department of Public Works and one retained by the District. The secretary, following instructions, purchased a seal for the District. The seal makes a circular imprint, showing the name of the district, date of organization and town in which the district office is located.
