Minutes of the previous regular meeting of November 12, 1969 were read and approved.

Bills in the total amount of \$9,563.67 were read, approved and ordered paid by the motion of Director Orlopp, seconded by Director Dial. Motion carried.

The Secretary reported that the \$50,000.00 in a time deposit which became due on December 7, 1969 was deposited in the General Fund.

It was moved by Director Beach, seconded by Director Orlopp, to deposit \$50,000.00 in a time deposit to mature on June 30, 1970. Motion carried.

It was moved by Director Dial, seconded by Director Beach that effective January 1, 1970 emphoyees will be paid as follows:

Earnings for the first half of the month will be paid on the 16th of the month, and earnings for the last half of the month on the 1st of the following month. Motion carried.

Istwas moved by Director Orlopp, seconded by Director Beach to recind the motion adopted on November 12, 1969 regarding the closing of the water charges on November 30, 1969 and adopt the following:

That a charge of \$3.50 per acre foot be made for unused 1969 water, and that the books be closed as of December 13, 1969. Motion carried.

It was moved by Director Orlopp, seconded by Director Beach that the meeting be adjourned until Wednesday, December 24, 1969 at 10:00 A.M. Motion carried.
