Ron Schneider was instructed to check with Tom Berry Co. of Visalia regarding this 11 B pump and obtain a cost figure.


A discussion was had regarding the purchase of a backhoe. After a discussion, this matter was continued until the February meeting.

Motion carried.

It was moved by Director Beach, seconded by Director McFarlin to pay the U.S.B.R. \$41,160.00 by March 1, 1977 for 23,520 acre feet of water (60% of 39,200 A.F.) at \$1.75 and authorize payment of \$13,545.00 for 1976 carry over water (3,870 at \$3.50). Motion carried.

It was moved by Director Orlopp, seconded by Director Ketscher to authorize mailing of State Well Report forms to all land-owners if it proves necessary as of March 1, 1977. Motion carried.






It was moved by Director Orlopp, seconded by Director Chase to purchase 4 used mobile radios from Cook's at \$950.00 each. Motion carried.
