Minutes of the regular meeting of December 13, 1978 were read and approved.

Bills in the total of \$36,631.00 were read, approved and ordered paid, by the motion of Director Ketscher, seconded by Director McFarlin Motion Carried.

The status of the Cash Plan was discussed. On the motion of Director Beach, seconded by Director McFarlin, the Revision #1 dated January 9, 1979 was approved. Motion carried.

Resolution 1-79: Re the transfer of Monies from the checking account to the Purchase of Time Deposits.

The status of water was discussed.

Resolution 3-79: Re the charging of a Fee for service for the delivery of water to Irrigation users.

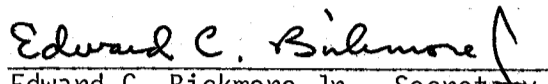
The Public Hearing was adjourned and the regular meeting of the board resumed with the Maintenance and Repairs Report presented to the board by Ron Schneider.

Minutes of the regular meeting of the Board of Directors of Orange Cove Irrigation District held on February 14, 1979.

The meeting was called to order at 10:00 A.M. with the following officers present: President Harvey S. Chase, Directors D.W. Ketscher, Stanley Beach, Richard McFarlin, Oscar Orlopp, Secretary Edward Bickmore and Attorney Peter Mook.

The minutes of the regular meeting of January 10, 1979 were read and approved.

Bills in the amount of \$ 29,009.13 were read, approved and ordered paid on the motion of Director McFarlin, seconded by Director Beach. Motion carried.

The Secretary made a report on the financial status and the status of the District's Cash Plan.

The status of water was discussed.

On the motion of Director Beach, seconded by Director McFarlin, the Board adopted the following water schedule for 1979:

Total 39,200 acre feet. Motion carried.

The Secretary reported to the Board on the conference held in San Francisco of ACWA districts which were interested in forming a Joint Powers Insurance Authority to self insure member districts for liability and possibiltiy other insurance coverages. On the motion of Director Ketscher, seconded by Director Orlopp, the President was authorized to sign the Joint Powers Agreement for the district, and the payment of \$750.00 was authorized to pay the district's share of costs in implementing the Joint Powers Insurance Authority. Motion carried.

Director Orlopp moved that a letter of formal protest be sent to the Boards of Directors of Terra Bella I.D., Delano-Earlimart I.D., Lindmore I.D., Lindsay-Strathmore I.D., and the Southern San Joaquin Municipal Utility District expressing our concern with their having formed a consortium of districts to develop power at Friant Dam without notice to the other Friant Water User Districts, and excluding these other districts from their project. Director Ketscher seconded the motion. Motion carried.

The Secretary informed the Board of the exploratory work being done to see if it is feasible to develop water and power on the Jackass and Chiquito creeks in the water shead area above Mammoth Pool. Director Ketscher moved that Orange Cove I.D. join with other districts to continue this project and authorized the District to pay \$3,200.00 as our share if this project is continued. Director Orlopp seconded the motion. Motion carried.

On the motion of Director Beach, seconded by Director McFarlin, the Secretary was authorized to respond to the Auditor-Controller, Fresno County, advising him that OCID had levied an assessment and standby charge for the period July 1, 1978 to December 31, 1979. Motion carried.

The following legislative bills were reviewed. The Board adopted the positions notied on the the motion of Director Beach, seconded by Director Orlopp. Motion carried.

On the motion of Director Beach, seconded by Director Ketscher, the Board agreed to donate an additional \$50.00 for a total of \$150.00, to Western Water Educations Foundation. On a roll call vote all Directors voted AYE, no NOES, and no ABSENT.

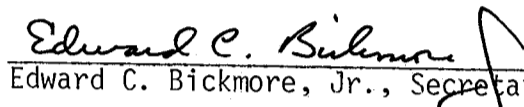

The manager reported to the Board that the pump at Turnout 6-1 had been severely eroded away, was not usable and was not worth repairing. On the motion of Director Beach, seconded by Director McFarlin, the manager was authorized to contact several pump dealers and to replace the old pump at his discretion, but as economically as possible. Motion carried.

The agreement with Karrie Mishler for janitorial services was reviewed and the President was authorized to sign the agreement. Motion by Director Beach, seconded by Director Ketscher. Motion carried.

On the motion of Director Orlopp the meeting was adjourned to reconvene at 10:30 AM on February 15, 1979. Seconded by Director Beach. Motion carried.

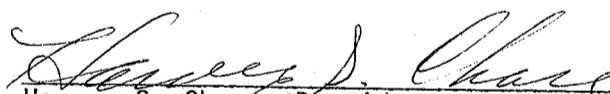

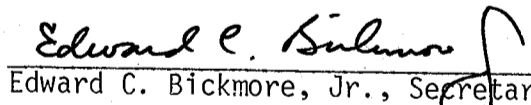
Attorney Fred Morgan was welcomed to the meeting.

Minutes of the regular meeting of the Board of Directors of Orange Cove Irrigation District held on March 14, 1979.

The meeting was called to order at 10:00 A.M. with the following officers present: President Harvey S. Chase, Directors D.W. Ketscher, Stanley Beach, Richard McFarlin, Oscar Orlopp, Secretary Edward Bickmore and Attorney Peter Mook.

The minutes of the regular meeting of February 14, 1979 and the adjourned meeting of February 15, 1979 were read and approved.

Bills in the amount of \$188,235.50 were read, approved and ordered paid on the motion of Director Beach, seconded by Director Ketscher. Motion carried.

The status of water was discussed.

On the motion of Director McFarlin, seconded by Director Ketscher, Harvey S. Chase was designated as the district's "member" of the ACWA Joint Powers Insurance Authority and Edward C. Bickmore, Jr., was designated as the "alternative". The expenses incident to the attendance of regular JPIA meetings were authorized for reimbursement from district funds. Motion carried.

RESOLUTION 4-79 RE: the joining together with other Irrigation Districts to investigate the feasibility of a Jackass-Chiquito water and power project.

Secretary-Manager Edward Bickmore was designated to represent the District in all matters concerning the Jackass-Chiquito projects during the preliminary phases. Motion by Director Beach, seconded by Director Orlopp. Motion carried.

Director Beach moved that the "Madera" decal modified to remove the grapes and cotton in the foreground be adopted as the Orange Cove Irrigation District's official decal. The Secretary was authorized to obtain a ten year supply of these decals at the most reasonable price available. The motion was seconded by Director Ketscher. Motion carried.

It was reported to the Board that the Auditor-Controllers Office, Fresno County had sent Orange Cove Irrigation District a check for \$16,522.38 for the first installment of property taxes collected by the county.

Director Orlopp moved that the District send a check to the San Joaquin Valley Agriculture Water Committee for \$280.00 as our pro-rata share of the costs for the Bookman-Edmanston Report on water resource management in the San Joaquin Valley. The payment of these funds is not to be construed as an acceptance of the committee's position or to authorize the committee to speak for OCID in ground water matters. Motion seconded by Director Beach. Roll call vote as follows:

The map of planned improvements to 11 B Ditch was reviewed and it was noted that an open meeting with the landowners of the District is scheduled for Wednesday March 28, 1979 at 7:00 P.M. in the District Board Room.

The letter from Mr. Vortmann requesting the refund of \$103.38 was read and discussed. The board determined that there has never been a Board policy on refunding money to its customers after purchase and prior to or during the next water season. The Board instructed the Secretary to prepare a Board policy of (1) not giving cash refunds to customers, unless specifically requested after the end of the water season and prior to the sale of water for the next season, (2) not giving cash refund to any customer who has purchased water or placed a deposit for water until the end of the next water season, unless that customer sells his property. On the motion of Director Orlopp, seconded by Director McFarlin, the Secretary was instructed to have a check prepared for Mr. Vortmann for \$103.38 and submitted at the next regular board meeting for signature. The Secretary was further instructed to advise Mr. Vortmann of the Districts policy in this matter. Roll call vote as follows:

Minutes of the regular meeting of the Board of Directors of Orange Cove Irrigation District held on April 11, 1979.

The meeting was called to order at 10:00 A.M. with the following officers present: President Harvey S. Chase, Directors D.W. Ketscher, Stanley Beach, Richard McFarlin, Oscar Orlopp, Secretary Edward Bickmore and Attorney Peter Moock.

The minutes of the regular meeting of March 14, 1979 were read and approved.

Bills in the amount of \$ 46,690.45 were read, approved and ordered paid on the motion of Director Ketscher, seconded by Director Orlopp. Motion carried.

Bob Williams, CPA of Baker, Peterson & Franklin presented the financial statements for the year ended December 31, 1978. It was called to the Board's attention that this was the first time his firm had been able to render an unqualified opinion on the financial condition of the Orange Cove Irrigation District since they began auditing the District records.

The Secretary presented a report on the status of LOCAL AGENCY INVESTMENT FUNDS invested with the State of California for the period June 20, 1978 to March 31, 1979. It was reported that the District had received \$5,340.83 in interest in the nine plus months since the District began it's CASH planning to invest it's idle funds.

The status of water was discussed. It was noted that the USBR had declared a 100% CLASS I and 70% CLASS II year.

The Secretary-Manager reported to the Board on the status of underground water in the District. Graphs of 60 test wells were reviewed for an 11 year period January 1968 to January 1978. The average change for the District as a whole is an overdraft of 7.1 feet in eleven years for an annual rate of .6 of a foot.

Secretary Bickmore and Attorney Moock reported to the Board on the progress being made on the formation of the Joint Powers Authority forming the "Upper San Joaquin Water and Power Authority". (Formerly JACKASS - CHIQUITO PROJECT)

Director Orlopp moved that the wording of RESOLUTION 4-79 paragraph 3 be revised to enable the District to pay it's \$3,200.00 share to the "Upper San Joaquin Water and Power Authority by deleting the following words:

"of incurred costs, excepting an amount which is authorized to be disbursed initially to reimburse costs to date to bring the District to an equal contribution basis with the original five Districts."

The motion was seconded by Director Ketscher. Motion carried.

Director Orlopp moved that the District draw a check in favor of Terra Bella Irrigation District for \$3,200.00 to pay OCID share of "Upper San Joaquin Water and Power Authority " fees due on or before April 15, 1979. Motion seconded by Director Beach. Motion carried.

On the motion of Director Orlopp, seconded by Director Ketscher, Director Harvey S. Chase was designated as OCID member to the Joint Powers Authority to be formed as the "Upper San Joaquin Water and Power Authority." Motion carried.

Manager, Edward C. Bickmore, Jr. was designated "Advisory Committee Member" to the "Upper San Joaquin Water and Power Authority" on the motion of Director McFarlin, seconded by Director Beach. Motion carried.

Director McFarlin moved that Attorney Peter Moock be authorized to attend "Upper San Joaquin Water and Power Authority" formation meetings as our legal representative. Expenses incurred are to be shared on a pro-rata basis with the other Districts he represents. Motion seconded by Director Ketscher. Motion carried.

The Board advised Attorney Moock of the following positions the Board prefers in the preparation of the Joint Powers Authority agreement:

- 1) Only long term Friant contractors should be allowed to participate.
- 2) Each District, regardless of size should participate equally with all other Districts.
- 3) If a District member decides to drop out, the monies it has invested at that time be returned at such time as the project starts receiving revenue above and beyond it's costs.

Motion by Director McFarlin, seconded by Director Ketscher. Motion carried.

Reports were made on the status of the District decal, the meeting with Improvement 11 B Ditch landowners, and the Joint Powers Insurance Authority formation meeting. No action taken on these matters.

The Secretary read the cover letter, from Attorney Fred Morgan of March 20, 1979 and the enclosed letter from MARSH, MASTAGNI & MARSH attorneys for the International Brotherhood of Electrical Workers dated March 12, 1975 setting forth the union's position. It was moved by Director Ketscher, seconded by Director Beach that the Board not accept the union's proposal and that Attorney Mook and Attorney Fred Morgan should confer and agree on legal representation for the District in the matter of IBEW Local 1245 v. Orange Cove Irrigation District. The name of such legal representative should be made available to the Board as soon as possible. Motion carried.

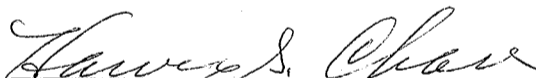

RESOLUTION 7-79 RE: Opposing the inclusion of the U.S. Forest Service into the Department of Natural Resources.

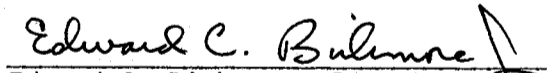

Bills in the amount of \$44,403.77 were read, approved and ordered paid on the motion by Director McFarlin, seconded by Director Beach. Motion carried.

The status of water was discussed.

Attorney Mook reported to the Board on the progress of the formation of the Joint Powers Agreement for the "Upper San Joaquin Water and Power Authority".

Attorney Mook reported on the status of IBEW Local 1245 vs. Orange Cove Irrigation District.

Secretary Bickmore read Attorney Fred Morgan's letter to Harry M. Marsh of Marsh, Mastagni & Marsh, of April 18, 1979 re: IBEW Local 1245 vs. Orange Cove Irrigation District and Fred Morgan's letter to E.C. Bickmore, Jr., of April 12, 1979 re: conclusion that he cannot serve as attorney since he was a member of OCID negotiating team at "meet and confer" sessions.

Director Ketscher moved and Director Orlopp seconded the motion to repay Chowchilla Water District 2,953 A.F. in accordance with our agreement of May 19, 1977. Motion carried.

Director Ketscher moved that the Secretary be authorized to revise the water schedule to reflect the repayment of Chowchilla water and to schedule the movement of up to 4,000 A.F. of water for sale to Tulare I.D. in August 1979 or as soon as practicable. Motion seconded by Director Orlopp. Motion carried.

On the motion of Director Ketscher, seconded by Director McFarlin, the following properties were invited to join their respective improvement districts at the current book value. Amounts shown are applicable through June 30, 1979.

The District sedan is used for District business and on a limited basis for the manager's personal use. The consensus of the Board was that this policy was adequate.

The meeting was called to order at 9:30 a.m. with the following officers present: President Harvey S. Chase, Directors D. W. Ketscher, Richard McFarlin, Oscar Orlopp, Secretary Ed Bickmore, and Attorney Walter McCormick.

The minutes of the regular adjourned meeting of May 7, 1979, were read and approved.

Director Beach arrived.

Bills in the amount of \$ 36,344.03 were read, approved, and ordered paid on the motion of Director Orlopp, seconded by Director McFarlin. Motion carried.

The Secretary made a report on the financial status of the district and the status of the districts cash plan.

The status of water was discussed. It was noted that the district was still 132AF short of having enough water to repay Chowchilla Water District their 2953 AF from the 1977 water season.

On the motion of Director Beach, seconded by Director McFarlin, the board accepted the ACWA JPIA proposed deposit for insurance of \$7,186.00 for the first year and authorized President Harvey S. Chase to sign the Joint Powers Agreement on behalf of Orange Cove Irrigation District.

RESOLUTION 9-79 RE: Entering of a Joint

Director Beach moved that the district ratify the previous selection of Harvey S. Chase as member and Edward C. Bickmore Jr. as alternate member to the ACWA JPIA. Director McFarlin seconded the motion. Motion carried.

Director Orlopp moved that the district approve the nomination of Edward C. Bickmore Jr. as a member of the ACWA JPIA finance committee. Director Beach seconded the motion. Motion carried.

Director Ketscher moved and Director Orlopp seconded the motion to pay expenses for the member and alternate member to ACWA JPIA meeting in Los Angeles on June 15, 1979 and to pay the regular per diem rate for the meeting to Director Harvey S. Chase. Motion carried.

Six constituents of Orange Cove Irrigation District presented an oral discussion of problem areas within the district. The Board noted their grievances and thanked each one for taking the time to attend the meeting of the Board.

It was moved by Director Ketscher, seconded by Director McFarlin that the district office be open for water orders and that water tenders make normal order changes on any holiday which falls on Monday or Saturday. Motion carried. (It was noted that this would only affect Labor Day, September 3, 1979 in this water season.)

Attorney McCormick addressed the Board concerning the resignation of Peter Mook. He advised the Board that his firm could not replace Mr. Mook, but that he would help the district find suitable representation. Attorney McCormick asked to be excused for the remainder of the meeting.

The Board recessed for lunch.

The Board reconvened at 2:00 p.m. June 13, 1979 with all original Officers and Directors present less legal council.

Director Beach motioned that the board accept and President Harvey S. Chase be authorized to sign the Upper San Joaquin River Water and Power Authority Joint Powers agreement on behalf of Orange Cove Irrigation District. Director McFarlin seconded the motion. Motion carried.

RESOLUTION 10-79 RE: Approving Joint Exercise
of Powers Agreement.

On the motion of Director McFarlin, seconded by Director Ketscher, the Board ratified the appointment of Harvey S. Chase as member, Oscar Orlopp as alternate member, and Edward C. Director Ketscher moved and Director McFarlin seconded the motion to pay USJRWPA member, alternate member, and advisory committee member expenses and to authorize per diem for member and alternate member for June 18th meeting. Motion carried.

The Board met in Executive Session.

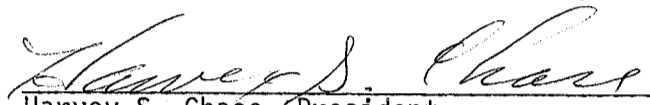

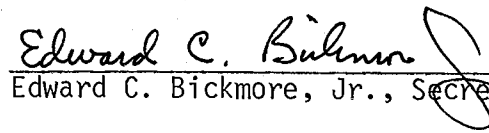
Minutes for June 13, 1979, continued.

The final part of the document provides a detailed summary of the findings. It highlights the key trends observed in the data and discusses the implications of these findings for the industry as a whole. The author concludes by offering several recommendations for future research and practice.

Mr. Jensen is to submit monthly billings to the district and no set retainer fee is authorized. Motion carried. The Secretary was instructed to inform Mr. Jensen of the board's action in this matter and to request Mr. Jensen to prepare a working agreement to cover his representation of the District, to be presented at the August meeting.

The Status of Water was discussed. The Secretary advised the board that the district's water conditions would now permit the transfer to the Chowchilla Water District of 2953 A.F. Director Ketscher moved that the district transfer 2953 A.F. of water to Chowchilla Water District during the month of August 1979. The cost of this water is to be \$3.50 per acre foot for a total of \$10,335.50. President Harvey S. Chase and Secretary Ed Bickmore were authorized to sign the agreement for the district. Motion seconded by Director Beach. Motion Carried.

One landowner in the district, present at the meeting, orally presented his grievances to the board stating his desire to order water and make changes on all holidays during the water season and objected to the district office being closed on the 4th of July.

The Board met in executive session to discuss:

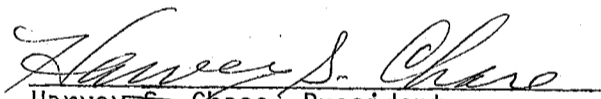

The board instructed the secretary to contact Attorney Doug Jensen to review the district's legal position and to prepare a letter to each landowner responsible for the tail water discharge expressing the district's concern with the problem and asking each landowner to control the spreading of water to minimize any tail water discharge.

Director Ketscher moved that the manager be authorized to purchase 200 A.F. of Class I water from Garfield Water District at \$3.50 per acre foot, and 700 A.F. of Cross Valley Water from Lower Tule River Irrigation District at \$15.00 per acre foot. Director Ketscher further moved that the manager be authorized to obtain up to 500 A.F. of next year's supply of Class I water if such an action is considered necessary to keep the district in operation through November 10, 1979, and if there has been no appreciable rain before that time. The matter of the South Avenue Annexation was brought to the board's attention in that Boyle Engineering, representing FREEDOM HOMES had contacted the district. 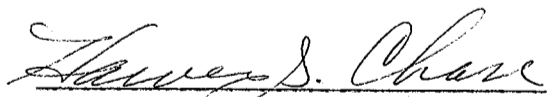

The meeting was called to order at 9:30 A.M. with the following Directors and officers present. President Harvey S. Chase, Directors D.W.Ketscher, Richard McFarlin, Oscar Orlopp, Secretary Ed Bickmore, Attorney Doug Jensen.

The minutes of the regular meeting of October 10, 1979 and the special meeting of November 7, 1979 were read and approved. Bills in the amount of \$43,696.12 were read, approved and ordered paid on the motion of Director McFarlin, seconded by Director Ketscher. Motion carried.

The Secretary made a report on the financial status of the District and the status of the District's CASH PLAN.

The status of water was discussed. The Manager recommended and the Board agreed that November 21 would be the end of the current water season unless sooner terminated by weather conditions. It was further agreed that any water remaining at the end should be sold, if possible, to other districts.

Tom Horne, District Engineer, reported to the Board on projects in Improvement Districts 1A, 3A and 11A. The Secretary was instructed to call a landowners meeting for ID 1A to see if enough landowners are interested in the recommended improvements.

On the issue of repairs to ID 3A, since most of the ID is owned by absentee landowners, the Secretary was instructed to write a letter to each landowner setting forth the problems with the system. The letter should also solicit interest in forming a new improvement district to replace the system in use. On ID 11A repairs it was determined that replacing a section of about 500 feet with plastic pipe would be the most feasible way to correct the problems with the present line. The Board was again advised of the possible conflict of interest by Fred A. Morgan possibly being both an attorney and witness in the case of IBEW v OCID. On the motion of Director Orlopp, seconded by Director McFarlin, the Board authorized Fred A. On the motion of Director Orlopp, seconded by Director McFarlin, the Secretary was instructed to send a letter to the advisory committee expressing the Boards concern with adverse public relations if the Board does not have the authority to settle minor claims directly without having to have these minor claims adjusted by GAB. Motion carried.

Director McFarlin moved that the district's representative to the Upper San Joaquin River Water & Power Authority be authorized to committ OCID for an additional \$6,000.00 as our fair share of costs incident to developing the Jackass-Chiquito Power Project. Director Orlopp seconded the motion. Motion carried.

The request for inclusion of approximately 32.11 acres into OCID by TEE DEE ranch was recognized and ordered filed.

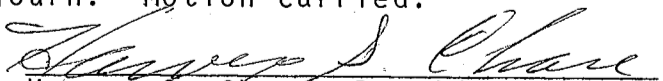

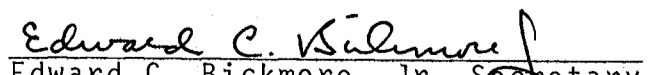

The meeting was called to order at 9:30 A.M. with the following Directors and officers present: Director Richard McFarlin, Secretary Ed Bickmore.

There not being a quorum present the meeting was adjourned to meet again at 9:30 A.M. December 15, 1979.

Minutes of the regular adjourned meeting of the Board of Directors of Orange Cove Irrigation District held on December 15, 1979.

The meeting was called to order at 9:30 A.M. with the following Directors and officers present; President Harvey S. Chase, Directors D.W. Ketscher, Stanley Beach, Richard McFarlin, Oscar Orlopp, Secretary Ed Bickmore.

The minutes of the regular meeting of November 14, 1979 were read and approved.

Bills in the amount of \$ 52,638.58 were read, approved and ordered paid on the motion of Directors McFarlin, seconded by Director Beach. Motion carried.

The Secretary made a report on the financial status of the District and the status of the Districts' Cash Plan.

The status of Water was discussed. The Secretary reported on the final cost of water for the 1979 water season and reported that there was 387 acre feet of water left over. On the motion of Director Ketscher, seconded by Director Orlopp, the Manager was instructed to sell the remaining water at the best price he could get. Motion carried.

Mr. Peter Dutton, Business Representative for I.B.E.W. Local 1245 was present and addressed the Board after the Secretary had read Mr. Duttons letter of December 7, 1979. Mr. Dutton pointed out the advantages of the proposals his letter had cited and requested the Board to take favorable action.

The Board met in executive session with Secretary-Manager Ed Bickmore to discuss the Union proposals.

Engineer Tom Horne reported to the Board on the meeting with District 1A landowners on December 11, 1979. Director Ketscher moved and Director Orlopp seconded the motion to proceed with the repair of approximately 375 feet of the pipeline and to call for bids from contractors to make the repairs. The manager was hereby authorized to accept the lowest bid received and to expedite the repair in any way feasible. Motion carried.

Director Orlopp moved that the funds previously and subsequently received by the District from Fresno County Tax Collector be placed in a Special Fund available to the Directors for special projects. Director Ketscher seconded the motion. Motion carried.

Director Ketscher moved that any monies needed to pay for I D IA repairs be advanced by the Special Fund during the time the District was collecting the funds from I D IA landowners. Director Orlopp seconded the motion. Motion carried.

The Secretary was instructed to contact attorney Doug Jensen to determine the necessary procedure to be followed by the District to obligate, bill and collect funds for I D IA repairs.

The engineer reported on the status of the Districts' HOPTO and discussed how we would keep two repair crews working with the Districts' two diggers.

SCB *The Board reconvened. Mr. Dutton was advised by President Harvey Chase that the Boards' most recent offer, as negotiated by the Districts' labor committee, had been reviewed by the Board and that the terms and conditions of employment of the new proposed agreement were considered to be very fair and equitable and that the Boards' position was firm. After some further discussion between Mr. Dutton and President Harvey Chase, the Board thanked Mr. Dutton for appearing before them. Mr. Dutton left the board room.

The Manager requested authority to hire four temporary part-time employees for the repair force during the off-season. Director Orlopp so moved with Director Ketscher seconding the motion. Motion carried.

The Engineer discussed the advantages of stock piling plastic and concrete pipe in the back lot of the Districts compound. He pointed out the cost savings which the District could get by purchasing in car load lots. Director Ketscher moved that the District make car load purchases whenever it was to the Districts' advantage to do so. Director McFarlin seconded the motion. In the discussion it was pointed out that plastic pipe deteriorates if exposed to the heat or sun for long periods. Director Ketscher approved the addition to his motion that suitable storage facilities be prepared in which the pipe is to be stored. Director McFarlin seconded the addition to the motion. Motion carried.

The Secretary reported that the Districts' Attorney had advised Golden Farms that the District would accept settlement of the claim for damages to the Districts' sedan for \$1,600.00.

The Secretary reported on the Notices sent to landowners on annual assessments, the USBR Water Users Conference to be held on January 22-25, the cost of water for 1979 and the mailing out of year end statements.

President Chase and Secretary Bickmore reported to the Board on the current status of the Upper San Joaquin River Water and Power Authority.

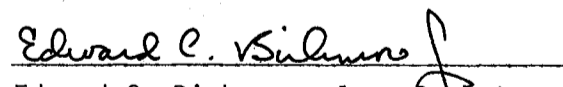
Secretary Bickmore advised the Board that recent changes in accounting requirements provided that Accounting Reviews could now be made in lieu of Audits where permitted by law and acceptable to the Directors of local agencies. Attorney Doug Jensen advised the Secretary and requested him to report to the Board that there was no legal requirement that Irrigation Districts be audited annually; however, it was customary to do so. However, Irrigation Districts are required to submit the annual State Controllers Report which has customarily been prepaid by outside accounting firms. Bob Williams, CPA of Baker, Peterson, and Franklin has advised the Secretary that the cost of a REVIEW will be considerably less than the fees ²⁰⁰ for an AUDIT. After considering the above, Director Ketscher moved and Director Beach seconded the motion that an ACCOUNTING REVIEW be conducted for the year ended December 31, 1979, and that the State Controllers report be prepared. The Secretary was ordered to so inform the Districts outside accountants. Motion carried on roll call vote. All Directors voting AYE.

The Secretary discussed the forthcoming Maintenance Billing which is due December 31, 1979 and delinquent January 31, 1980. By consensus the Board concluded that no interest charges would be charged to those Districts which had had monies advanced to cover the maintenance costs.

The Board discussed with the Manager the performance of the engineer, Thomas Horne, and reviewed his compensation. Director Ketscher moved and Director Orlopp seconded the motion to give Mr Horne a \$100.00 per month raise effective December 1, 1979. Motion carried.

There being no further business, it was moved by Director Orlopp, seconded by Director Beach to adjourn the meeting. Motion carried.
