The meeting reconvened at 1:30 P.M. with Attorney Leroy McCormick present.

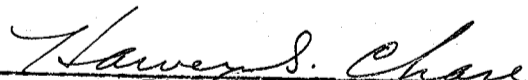
A discussion was had regarding the U. S. B. R. policy for 1956 water season.

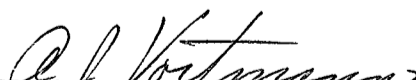
S. Hiyama was present and discussed his claim for damages.
